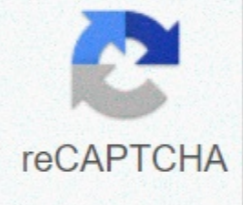

This information includes: Your loved one is the full legal name (first, middle and last) Their date of birth Constructure in which they are held in Know that some tools may suggest or require additional information from you about your loved one, depending on the individual circumstances When we go through this list, we will clarify what this information is and where it is applicable. And now the tools to place the prisoner. As we said, the BOP search tool displays results only for federal prisoners. To find an inmate who is being held in a local prison or state prison, you will need a government website. State prisons can vary in their trial. The general process of finding your loved ones can be seen with a few examples: Here's what you'll need if your loved one is trapped in New York: Note that the department ID number or New York State ID number are intended to be used on your own. In other words, if you include any of these numbers, you do not need to indicate the name and year of birth of the prisoner. Similarly, to find inmates in California, you will need to enter either their full legal name or their inmate number if you know this: While most states provide the ability to search prisoner on their official government website, others use a third party search tool, which we will discuss in the next section. The Bureau of Prisons allows you to search a database of federal inmates to find your loved one and reveal his contact information. Note that this database only contains inmates held in federal prisons - we'll get to smaller prisons and prisons in a moment. The BOP database also contains information on prisoners who have been released, going back to 1982. When using the BOP search tool, you can search for prisoners by name or by different identification numbers. First, we search for prisoners using their name: Again, searching for a common name without further information leads to a large number of search results. Also note that the search engine limits the number of results to 100 - meaning a lot of other prisoners named John Smith don't even show up. Obviously, it is not likely that you will face this problem, but it is certainly good to know. In any case, you can also narrow your search by include the race, age, and gender of your loved one. Because this search tool does not offer any advanced search features, you may need to include this information in order to display fewer than 100 results. You can also search for a federal inmate using a number of different identification numbers, such as: BOP Registration Number CDCR NUMBER FBI NUMBER INS, because these identification numbers, of course, belong exclusively to your loved one, using this method is the best way to generate accurate results from the BOP site. Crime statistics for Tarrant County show there were 3,038 violent crimes and 27,403 property crimes in 2015, the most recent year with a full record. These figures represent a slight decrease in the violent crime rate of 0.6% and a more significant reduction in the property crime rate of 7.2% compared to the previous year. The most common violent crime in the county in 2015 was violent crime with 1,812 incidents. There were also 794 robberies, 415 rapes and 17 murders during the same period. A closer look at property crimes in Tarrant County shows that theft was the most pre common crime with 21,107 cases. The burglary was a distant second with 4522 incidents followed by vehicle theft (1774) and arson (65). Compared to the previous year, there was a lower incidence of homicides (32%), aggravated assault (4%), burglary (7.2%) and arson (1.5%). However, the county recorded higher rape (9.2%), robbery (3.8%), theft (0.05%) and vehicle theft (2.4%) Rates. The Tarrant County Sheriff's Office provides background checks to interested parties. This unit monitors and registers all sex offenders living in unregistered areas of Tarrant County, including River Oaks, Edgelynn Village, Haslet and Benbrook cities. To find individual sex offenders residing in the county, visit the Texas Department of Public Safety (TxDPS) website. The Agency shall be responsible for maintaining a national database of registered sex offenders and shall make this register available to the public. Use to search for sex offenders to find specific offenders or to view all registered sex offenders on a county map. The search tool is also useful for searching for all sex offenders living around colleges and university campuses throughout the county. The Tarrant County Sheriff's Office is responsible for keeping all inmate records for the county. It provides a handy prisoner locator tool on the county's website. Use it to find individual prisoners by name, reservation number, race and gender. Court Records Tarrant County hosts its court records on a publicly available portal. This judicial records search tool provides access to criminal and civil case documents as well as court calendars. In addition to this free self-service document search, the district clerk also offers another online paid service that covers a wider range of court records. Available documents include records of all 27 civil, criminal, misdemeanor, delinquent taxes and family district courts in the county. The district clerk's office charges a \$120 initiation fee as well as a \$35 monthly fee for using the service. The public can also ask the county clerk to help with the search for court records. Each search attracts a nominal fee of \$5. The official accepts requests for copies of court records. There is a 50 cent fee for each page of uncertified copies, while the rate for certified copies is \$1 per page. The Public Records County Clerk is responsible for issuing vital records for Tarrant County. These records contain certified copies of birth and death certificates, as well as marriage certificates. To obtain a birth or death certificate, start by downloading and filling out a birth request or death record. This app is also available in Spanish. The fee for the first copy of the death certificate is \$21. Each additional copy of the same record attracts a \$4 fee. Clerk charges \$21 for the first copy of the marriage certificate and \$10 for each additional copy

ordered at the same time. To apply for a marriage license, download and fill out the online app. Transfer it to one of the above locations. The County Clerk also makes his marriage records database available to the public. Go to the Access marriage document page and search for issued marriage certificates. Visitors can search by candidate name, application date, marriage date, license number, and license status. Status.
