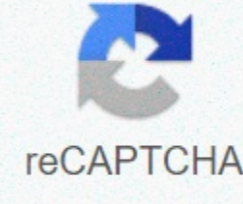

## Ohio bmv power of attorney title

The Ohio State Automotive Power of Attorney (Form BMV 3771) is a standard form to assign someone to represent the owner of the vehicle in front of the Bureau of Motor Vehicles. The purpose of such paperwork is to allow someone other than the owner of the vehicle to apply and gain ownership of the vehicle on behalf of the owner. While this may seem limited in scope, it can be quite useful in situations where the vehicle is purchased and the new owner of the vehicle cannot clear his schedule to participate in such procedures, but still has to complete the titillation process in a timely manner. 1 - The Ohio form for the purpose of the vehicle authority is on this Page The form required for this task is provided on this page. This statement provided three spaces to represent the signature date as a calendar day, month, and year. Next, the primary owner of the vehicle will have to sign his name into an empty line labeled Person's Signature giving power of attorney. After this task is complete, he or she physically enter your Social Security number on the line labeled Social Security Number Buyer/owner. The principal's signing must be assimilation. The area at the bottom of this page has been reserved strictly for the use of a notary by the public. If the owner of the vehicle wishes to introduce a power of attorney for vehicles in Ohio (Form BMV 3771), it must be submitted to the Ohio Department of Public Safety, the Bureau of Motor Vehicles. This document informs the Bureau of the desire of the vehicle owner to choose a lawyer to carry out and execute the assignment or application for their certificate of ownership. In addition, it grants the lawyer actually full authority to do and perform all the actions and things in general necessary, necessary and proper to do what the vehicle owner will do to complete or act independently. If the principal cannot present himself to the offices of the Ohio Bureau of Motor Vehicles, this form will allow the attorney to actually appear in their stead and sign any documents related to the titling or registration of a particular vehicle. It is necessary to enter the full names and addresses of the principal and the lawyer, as well as all the necessary information about the vehicle. Once completed, the form can be taken to the notary public for recognition.
