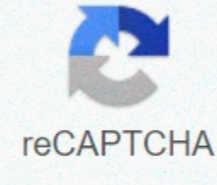

Kansas child support enforcement laws

Do you have a child support warrant in Georgia, but you don't receive payments? If you have already obtained a child support order and the unused parent does not pay, or if the person who ordered you to pay is late for payments, there are several tools at your disposal. Contact DCSS In Georgia Child Support Services is provided by georgia's Department of Human Resources, Department of Child Support (DCSS). If you already have a case with DCSS, contact the assigned case manager. When you try to apply an existing order, make sure you have a copy of the original order. A copy of the order can be obtained from the court office. The childcare enforcement unit has the power to collect the completed childcare (pledge) and to obtain health insurance through various administrative procedures without ever going to court. What can DCSS do to help enforce the support command? DCSS can do several things to parents who don't pay child benefit, including: withholding child support from wages or unemployment benefits; interception of federal and/or state income tax benefits to pay for child recovery.
