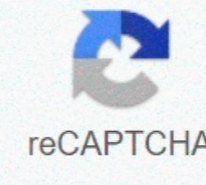

Dear TuSD Families, As we finish the current school year, we will now transfer our focus to planning for the 2020-2021 school year. Public safety and the safety of our students, staff and families remains our top priority. Torrance Unified convened the reopening of the school task force to develop options and plans for the 2020-2021 school year. While we are confident that students have better experiences when physically at school as they grow – academically, physically and socio-emotionally, we plan to provide families with other options as well. We recognize that information regarding COVID-19 is constantly changing and we continue to closely monitor the governor’s Stay at Home Order, the Los Angeles County Department of Public Health and the Los Angeles County Education Bureau guidelines. When we start planning for the coming school year, we would like to hear from our families. Please answer the survey question by Friday, May 29, 2020 (one per family) to help us in this process: 2020-2021 Reopening of the school study We will provide additional details on how to reopen the school as more information becomes available. Superintendent of Spanish translation schools Dear TUSD family, We hope this message will find you and your family healthy and well. In the summer and from the beginning of the academic year, we continue to plan and prepare for the possible return of our students to their classes. In late September, in accordance with guidelines set by the Los Angeles County Department of Public Health (LACDPH), we were able to welcome back a limited number of students to our campuses for in-person learning and special services. Over the past six weeks, nearly 900 students have been attending small learning cohorts (Special Education, English Learners, Homeless, Foster Youth, and other students). In addition, more than 400 student-athletes have returned to small air conditioning groups with teammates and coaches in each high school. At yesterday’s meeting, our Board gave direction to restore our TK-K and 1st grade students to start training in person. These classes will continue to follow the current Mixed AMPM schedule. We will expand our TK-1-focused working group to finalize plans for reopening to these younger students. We expect to return to school for TK and K students on December 7 and after the winter break for first-graders. Additional information with a valid questionnaire will be sent to tk-1 parents from school principals until tomorrow. In addition, the Board also decided to apply for a TK-2 exemption from the L.A. County DPH. This would allow us to bring back second-grade students. Process priorities with a higher percentage of free and reduced lunch (TUSD percentage varies from 10% to 61% depending on the school side) and allows only ten schools to be considered each week in the 4th district of the District Board of Supervisors. TUSD has 17 primary schools and we cannot predict when our primary schools will be approved for exemption. We will inform parents of further details as they go through the process. We are working with public health orders to safely restore students. We will continue to prepare for the return of the next classes, as these processes are approved by the L.A. County DPH. As you may know, on Monday, December 7, 2020, we will welcome our Blended Learning students (TK-K class) for instructions in person. Blended Learning first graders will return on January 4, 2021. We follow all protocols from the Los Angeles County Department of Public Health (LACDPH) and current modified stay-at-home orders that allow schools to continue to deliver, and gradually expand training into individuals. These protocols include limiting students on campus to no more than 25% of the school population.. For the full LACDPH press release, click here: Modified stay-at-home orders. According to LACDPH guidelines, we have already returned more than 1,500 students to our campuses every day since September. In addition, since August we have had ymca childcare classes in some schools. We continue to work closely with LACDPH, especially with the recent increase in COVID-19 cases in LA County. I would like to thank all our staff, students and parents for their cooperation that made this safe. This is a concerted effort by everyone in our school community! In order to provide additional information to employees and parents regarding COVID-19, we are working on a dashboard that will provide information on confirmed positive cases on the school’s website. Please look for this information, which will be published on the County website sometime next week. The health and safety of our students, staff and our community remains our top priority and I know that we will continue to safely expand our capabilities on campus for students. Please note that do not send your child to school (or anywhere in the community) if someone in your household has any symptoms associated with COVID-19. Together, we can ensure that our school is healthy and safe. Thank you for your unseated partnership and support at this time. I wish you and the best families in the weeks leading up to the holiday season. With respect, Tim Stowe Interim Superintendent of the Torrance Unified School District asked families of more than 23,000 students to make a decision by Monday, July 20, whether they prefer online-only instruction this academic year or a mixed approach that includes children returning to classes for part-time school weeks as well as part-time online studies. Students will be automatically placed in a mixed option - about 80% of parents indicated in surveys they plan to choose - unless families notify the district by Monday of their online-only selection preferences. County officials made the decision Monday, July 13, to begin planning for schools to reopen, sent an email to families Wednesday explaining the move and hosted two conference calls for parents Thursday to answer questions. The new state law requires districts to offer instructions in person as much as possible. Officials acknowledged that it was a difficult decision and meant that about 800 people joined the conference call on Thursday morning, which was aimed at families with children attending elementary schools. The new school year starts on August 26, but the Board of Education will decide on August 3 whether to reopen classrooms or not. The moves come amid growing cases of coronavirus and hospitalizations that are again threatening to overwhelm countywide hospitals. Health officials have again imposed restrictions on some businesses in an attempt to avoid the near-total shutdown that took place in March, which caused the economy to crash and caused huge job losses. Officials on Thursday, however, warned against reapplying stricter measures if people do not wear masks and do not physically hold on to others. Earlier this week, Long Beach Schools announced it would delay on campus training until at least October after consulting with local health officials. Los Angeles and San Diego unified school districts made the same decision this week, too. L.A. County health officials, though, have - for now at least - left open the possibility of some smaller school districts returning to teaching on the ground sooner than that. It’s not safe at the moment and we know that, said Kati Krumpke, Torrance Unified’s chief academic officer. No one will have students and staff go back to school if it’s not safe. But school officials said they must at least plan for this possibility, which is one of the reasons for the short time that parents have received to make a decision. TUSD has released an 18-page guide to help parents, which describes what the new normal education will look like if schools can reopen Only 16 students will be able to participate in one class at a time, which means that classes that usually have 27 students, divided into morning and afternoon sessions. Classes will take place four days a week, supplemented by distance learning. Based on current physical distancing protocols, you can’t start the 2020-21 school year in a traditional, five-day environment, said Interim Superintendent Tim Stowe in a message to parents. The district, meanwhile, is working with the YMCA to provide day care in schools. Individual schools are also preparing detailed plans tailored to their specific site - such as how students will use the restroom or eat dinner, for example - that will be sent to families in mid-August. Krumpke said. And, of course, most group activities, field trips and choir practices - the virus easily transmits through singing - are now banned. You have to choose (an education option) that’s right for your family, Krumpke said. You have asked you to trust us, she added, you entrust your children to us every day. RELATED CONDITIONS COVID-19: Close contact is defined as the person who was 6 feet away from the infected person for more than 15 minutes over a 24-hour period (even if non-medical face covering was worn) or contact with the body fluid and/or secretions of the infected person (coughing or sneezing), sharing a drink or kitchenware, or being a member of a class/cohort at exposure to a potentially infected person. Exposure is when you come into close contact with a person diagnosed or suspected to be covid-19. A person who has had unprotected contact with bodily fluids and/or secretions of a person with confirmed or suspected COVID-19 (e.g. cough or sneeze, share vessels or saliva or provide care without the use of appropriate protective equipment) or is a member of a class/cohort exposed to a potentially infected person. Insulation in the house required when a person is infected or suffering from COVID-19 and should be away from people who are not infected. A person who is in isolation is to stay at home until it is safe for them to be around others. Home quarantine is required for anyone who may have been exposed to COVID-19 and must stay away from others. Quarantine helps prevent the spread of a disease that can occur before a person knows that they are sick or if they are infected with the virus without experiencing symptoms. The person undergoing quarantine is to stay at home, separate from others, monitor their health and follow the instructions of the local health department. Department.
