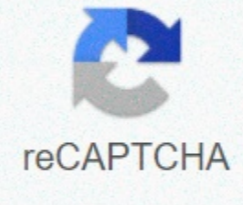

## Va private road maintenance agreement form

In previous blogs, we've addressed the difference between private travel and facilitation; New Hampshire's new law mandates residential private road maintenance in certain situations, and what private road maintenance agreements should include. Although the agreement is an important step, the establishment of an association can greatly simplify the management and implementation of private road maintenance agreements. Consider condominiums. Condominiums are usually a separate unit to handle things like 1) money, 2) sue for collection (if necessary), and 3) buying insurance (if necessary). An entity shall also provide a layer of protection for persons taking on an active role, both on the basis of the mere existence of the entity and the indemnity provision contained in the formation document. Without an association, the money must go to someone's current account, while an association can keep money in a separate account under the name of the association. When different people take the lead, the account and money do not move, new names are simply added as delegated signatories. Without an entity (association), one or more property owners must sue on their own behalf and then negotiate the cost with the other owners. Furthermore, lawsuits invite counterclaims. A counterclaim is effectively a new and separate action brought on behalf of the other owners against the person bringing the recovery action. The lawsuit must be defended, and its very existence may appear in someone's credit report. The association brings the lawsuit on behalf of the association, not the name of an individual. The association collects all judgments, places the money in the association's bank account and distributes it in accordance with the procedures adopted by the item owners. Insurance companies are used to issuing bonds to associations to protect the association's assets from damages and liability from its officials. Individual homeowners may otherwise need to rely on homeowner policies that have limited coverage beyond the home as well. The most common type of association used in New Hampshire's private road maintenance situations is based on a not-for-profit company RSA 292. Even though these entities are entities the name often uses the word association in the address. The company (association) can be created so that each owner of the item will automatically become a member of the company. (RSA 292 uses the term member instead of shareholder.) A simple policy would be adopted to address things like voting, meetings, and collections: Having an organization consists between criminal owners or injured parties and beneficial item owners provides a layer of protection for member/item owners. Insurance, however, is still prudent. Unless amended, both the formation of the organization and the adoption of the policy are one-off events requiring the signature of all property owners wishing to become members of the association. In other words, only those who agree to join the association are required to comply with the rules and regulations. That said, even if not all owners join, an association can still be useful in asserting existing alliances against those who do not join. The association can also be useful in enforcing the legal obligation of owners to contribute to the maintenance of private roads. Paul J. A private road is a road owned and maintained by an individual and not by the government. This is the most common type of private road we call residential roads, and is owned and maintained by the homeowners association. The private road is often built to gain access to a private property, but it can also be used by the public, depending on the conditions set by the owners.
