## WHAT IS THE FRAMEWORK OF OUR VALUES?

The 1973 Supreme Court *Roe v. Wade* decision ushered in abortion for any reason. This was because it saw unborn babies as non-persons, because they were passive and dependent existences. It made abortion on demand available nationwide.

## Some Rights are WRONG

In 1991, the United States Congress in a joint Resolution of both Houses affirmed that the United States is based on seven great biblical laws called the Seven Laws of Noah. These are named after the survivor of the Flood, Noah and his descendants - all humanity - with whom the Creator established a covenant based on these laws, upon which civilization would be established.



## HUMANITY AT RISK

Among these laws was a prohibition of killing, which includes abortion, except where it is required to save the life of the mother. In *Roe v. Wade*, the majority on the Supreme Court ignored the framework of these universal principles which prohibit abortion on demand as forbidden killing.

Will our society reaffirm these universal values or not?

The universal principles of the Noahide laws give unborn life an absolute value because life - even though it is passive and dependent - has a soul made in the image of its Creator. So it has absolute value even though it is passive and dependent. Life must be protected.



## Are We CRUEL or are we COMPASSIONATE?

Joe Biden and Kamala Harris want to make federal laws forcing all 50 states to allow a baby to be killed up to seconds before its birth. This often involves crushing the baby's skull or dismembering its limbs. They also supported a bill to allow babies that survive abortion to be left to die.

Biden and Harris portray abortion as an act of compassion. Those who have compassion for cruelty will end up being cruel to those who need compassion.

## Does life have absolute value or not?

There are other lives which are passive and dependent: The life of a child born with disability and the life of an adult in a coma or with a terminal illness. The thinking of the Supreme Court in *Roe v. Wade* opens the way to killing those with disabilities, because it gives no absolute value to human life.
