CHI Franciscan is a multi-facility healthcare organization located across Washington State encompassing nine inpatient centers:

Highline Medical Center, Burien;

Harrison Medical Center, Bremerton & Silverdale;

Regional Hospital, Burien;

St Anthony Hospital, Gig Harbor;

St Clare Hospital, Lakewood;

St Elizabeth Hospital, Enumclaw;

St Francis Hospital, Federal Way;

St Joseph Medical Center, Tacoma.

The regional education services department supports site and unit based educators and nurse specialists across all sites and specialty service lines. It is led by John Mueller, Division Director and includes eight educators, a nursing coordinator for nursing practice, two Learning Management System/instructional design staff, two administration support staff, and an audio-visual technician.

The department is responsible for coordinating the various service specific nursing residencies, nursing orientation and clinical education, regulatory education and training, and professional development activities. The department also supports non nursing and allied healthcare employee training.

We are located at the Franciscan Education and Support Center (FESC) in Tacoma WA, and in fiscal year 2017-18 we educated and trained over 46300 employees!
